

## **Eighth Judicial District Court-Family Division Seminar for Separating Parents**

The Seminar for Separating Parents (formerly referred to as the “COPE” class) provides curricula designed to help parents minimize the effects separation has on children and learn strategies to work cooperatively with each other for the benefit of the children. The Seminar is available in both English and Spanish and in person or online.

If a District Court Judge has waived the court and/or filing fees (or ordered that a person shall proceed *In Forma Pauperis*), the Seminar fee may also be waived. Seminar fee waivers are limited and available on a first come, first served basis. Participants must contact the provider directly to request the Seminar fee waiver before registering for the Seminar.
